STAGES AND PAYMENT TERMS:

Control fees are paid before the service is provided.

1. CCB AGRO ORGANIC CONTROL customers pay a basic fee for each check. In addition to the estimated shipping and business trip costs for the inspection, the costs associated with the costs of the CCB for the payment of the annual accreditation of the control body are added to this.
2. These costs up the annual certificate fee.
3. This fee is complemented by the payment of the service fee per decare depending on the type of crop or animal or beehive.
4. Additional time: Additional services required for inspection and certification caused by incomplete, inaccurate or incomplete information or documentation, or short notice to change the customer's control dates, may be charged as shown in Table 1.
5. Control-related activities not included in Table 1 (e. g. Poultry farming) will be paid on the basis of the required control time (55 BGN).
6. If inconsistencies with organic standards are detected during the inspection, the time required for random unannounced checks will be paid 55 BGN / hour (plus travel expenses).
7. Fees for sample analysis are borne by the customer at the service prices provided by the laboratory.
8. When sampling to confirm results that the operator could not otherwise verify, the costs of the analysis shall be borne entirely by the operator (GMO declarations, etc.)
9. Additional checks, time required and cost incurred (55 BGN / hour plus travel expenses, plus sample research prices) due to the existence of significant non-compliance with organic standards as a result of the imposed sanctions or additional studies.
10. Prices are in Bulgarian leva and are exclusive of VAT.
